In supersession of Government Order No. 619 (P) of 2008 dated 08-09-2008, Sanction is hereby accorded to the grant of rent in favour of Smt. Vaishno Raju W/o Shri Kuldeep Singh R/o H. No.117, Sector No.6 Channi Himmat, Jammu w.e.f. the date the rent has been stopped the house occupied by J&K Police deployed for IS/CI duties in the State as per the relevant rates applicable, subject to the following terms and conditions:-

1. That the payment shall be made after completion of all codal formalities and verification of particulars of the owner.
2. That the actual date with effect from which the rent has been stopped be ascertained from the concerned superintendent of Police/Commandant before the payment is released so as to ensure that no double drawal/payment is made.
3. That all the liabilities on account of electricity fee, water tax, lease premium, municipal tax, income tax, etc. have been liquidated by the owner. Necessary NOC's in this regard be obtained from the concerned and copies forwarded to Home Department for reference and record.
4. That the person in whose favour rent is sanctioned is exclusively the interested party and that she has not alienated her premises to any other person(s). An affidavit to this effect duly attested by Judicial Magistrate 1st Class be obtained and copies forwarded to Home department for reference and record.

5. That the expenditure shall be debited to Account Head 2055-Police 117 Internal Security (SRE) Rent of Accommodation.
6. That the police/Security forces deployed are performing IS/CI duties and are in actual possession of the said House.
