Subject: Final Seniority List of the Senior Superintendents of Police (Telecommunication Cadre) as on 01.01.2015.

Whereas, vide Government Order No. 264(P) of 2007 dated 15.06.2007, among others, two posts of Sr. Superintendents of Police (Telecom) in the pay scale of Rs. 12000-16500 (pre-revised) one each for Jammu and Kashmir were created; and

2. Whereas, prior to issuance of aforesaid order, there was no post of SSP (Telecom) existing in the Jammu and Kashmir Police (Gazetted) Service Recruitment Rules, 2002; and

3. Whereas, vide Government Order No. 414(P) of 2007 dated 30.08.2007 Shri Mohammad Yaseen and Shri Hilal Ahmad, SP(Telecommunication) were placed in the Pay Scale of Rs. 12000-16500 (Pre-revised) against the two newly ceated posts of SSP (Telecommunication) for a period of six months or till the posts were filled up under rules whichever is earlier; and

4. Whereas, vide another Government Order No. Home-233(P) of 2008 dated 08.04.2008, Shri Bhopinder Singh-II, Superintendent of Police, (Telecommunication) was placed in the Selection Grade of Rs. 12000-16500 for a period of six months or till the posts were filled up under rules whichever is earlier; and

5. Whereas, the placement of the three officers in the pay scale of Rs. 12000-16500 (pre-revised) was regularized vide Government Order No. Home-434 of 2013 dated 15.10.2013 on the recommendations of the J&K PSC, with effect from the dates indicated against each:-

Whereas, vide Government Order No. 224 of 2014 dated 20.05.2014, Shri Naseer Ahmad, SP (Selection Grade) was promoted as SSP (Telecom) in the Pay Band of Rs. 15600-39100 + Grade Pay of Rs. 7600/- with immediate effect. Similarly, vide Government Order No. 329 of 2014 dated 11.07.2014, Shri Manzoor Ahmad Shoori, SP (Selection Grade) was promoted as SSP (Telecom) in the Pay Band of Rs. 15600-39100 + Grade Pay of Rs. 7600/- with immediate effect; and

7. Whereas, the department has so far not issued seniority list at the level of SSP (Telecom) and the seniority at the SP level was being utilized for making promotions/placements beyond the scale of SP(Telecom); and

8. Whereas, Shri Mohammad Yaseen, and Shri Bhopinder Singh-II, Selection Grade SP(Telecom) have retired on superannuation w.e.f. 30.11.2009 and 31.01.2010 respectively. Besides, vide Government Order No. 76-Home of 2014 dated 08.02.2014, Shri Hilal Ahmad was promoted as Director Telecommunication in the Pay Band-4: Rs. 37400-67000 + Grade Pay of Rs. 8900/- with immediate effect; and

9. Whereas, vide Circular No. 01-Home of 2018 dated 21.05.2018, a tentative seniority list of the Senior Superintendents of Police (Telecommunication) Cadre as on 01.01.2015, as per Annexure-A to the said Circular was notified for information of the concerned officers with the stipulation, that any officer aggrieved with his position in the seniority, may represent within a period of ten days from the date of issuance of the Circular; and

10. Whereas, as per the records, no officer has represented against his position in the tentative Seniority List.

11. Now, therefore, a final seniority list of the Senior Superintendents of Police (Telecommunication) Cadre as on 01.01.2015, forming **Annexure-A** to this Government Order is hereby notified for information of the concerned officers/members. The date (s) of birth of the officers shown in the final seniority shall be subject to further verification from their Matriculation certificates (Date of Birth)/Service Book.

12. The final seniority list is issued without prejudice to the outcome of writ petition(s), if any, pending on the subject before any Court of competent jurisdiction.




