In the matter of discipline and appeal, the officer shall be governed by the J&K Civil Services (Classification, Control and Appeal) Rules, 1956 and J&K Employees (Conduct) Rules, 1971.

The appointee shall enter into an agreement as per the Schedule-II of the J&K Rajya-cum-Zila Sainik Board (Gazetted) Service Recruitment Rules, 1971 with Director, Sainik Welfare, J&K before taking up his appointment.
