Pursuant to the Cabinet Decision referred to above, sanction is accorded to the:-

- (i) Up-gradation of pay scale attached to the post of SG. Fireman from existing Grade Pay of Rs. 2100 to Grade Pay of Rs. 2400 in the Pay Band of Rs. 5200-20200 notionally with effect from 12-6-2017 and monetarily with immediate effect.
- (ii) Up-gradation of pay scale attached to the post of Leading Fireman from existing Grade Pay of Rs. 2300 to Grade Pay of Rs. 2800 in the Pay Band of Rs. 5200-20200 notionally with effect from 17-10-2014 and monetarily with immediate effect.
- (iii) Up-gradation of pay scale attached to the post of Sub-Officer from the existing Pay Band of Rs. 5200-20200 + GP 2800 to Pay Band of Rs. 9300-34800 + GP Rs. 4200 notionally with effect from 17-10-2014 and monetarily with immediate effect.
