Sanction is hereby accorded to the temporary appointment of Mr. Surinder Singh S/o Late Mr. Balwan Singh (Ex-Follower) No.F-02/TR-J (PID No.EXJ 945638) R/o Panjgrain Nagrota, District, Jammu, as Follower in the Pay Scale of Rs. 4440-7440 with the Grade Pay of Rs. 1300/- in J&K Armed Police in relaxation of prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the Director General of Police J&K, within a period of 21 days from the date of issuance of this order and shall be allowed to join only after production of the following documents/ certificates in original:-

- 1- Academic Qualification certificate.
- 2- Age and Health Certificate.
- 3- State Subject Certificate.
- 4- Certificate from the General Managers, DIC concerned and Deputy Director, Employment concerned to the effect that no Loan under Self Employment Schemes has been taken by him.

If, on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be treated to have been cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report about the verification of his Character and Antecedents is received from the Inspector General of Police, CID, J&K to whom a reference shall be made by the APHQ. He shall furnish an affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the IGP, CID, J&K, he shall have no right to claim the appointment and his appointment as Follower in the J&K Armed Police shall be deemed to have been cancelled ab- initio.

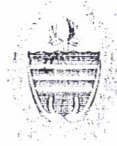
