Sanction is accorded to release of further funds to the tune of Rs. 144.21 lac (Rupees one crore forty four lac twenty one thousand) only along with advance drawal of the same amount in favour of the Director General of Police, J&K, out of balance provision of Budget Estimates 2015-16 under Major Head 2055-Police, Non-Plan (Normal), object head "O10-Material and Supplies" for purchase of 5000 gms gold and fabrication of 196 (one hundred ninety six) Sher-i-Kashmir Police Gold Medals.

The sanction is subject to the conditions that:-

- The expenditure shall be booked after observing all the codal provisions.
- The purchase/fabrication of Gold medals shall be made at most economical rates at approved scale and in accordance with the guidelines prescribed by the Government in this regard.
- The Red/Adjustment accounts are furnished to the Principal Accountant General, J&K within the prescribed time limit.
