Sanction is hereby accorded to the temporary appointment of Mr. Faizan Haneif Khan S/o Late HC Mohd Haneif Khan No.ARP-915579,IRP-7<sup>th</sup> Bn R/o Kuligam, Tehsil Lalpora, District Kupwara, as Follower, in the Pay band of Rs 4440-7440 with Grade pay of Rs 1300/- (Pre-revised) in J&K Police, in relaxation of prescribed qualification, in terms of Rule-7 of SRO-43 of 1994.

The appointee shall report to the Director General of Police, J&K within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates in original:-

1. Academic Qualification certificate.
2. Age and Health Certificate.
3. State Subject Certificate.
4. Certificate from the General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no Loan under Self Employment Schemes has been taken by him.

If, on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be treated to have been cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report about the verification of his Character and Antecedents is received from the Additional Director General of Police, Criminal Investigation Department, J&K, to whom a reference shall be made by the Police Headquarter. He shall furnish an affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General, Criminal Investigation Department, J&K, he shall have no right to claim the appointment and his appointment as Follower in the J&K Police shall be deemed to have been cancelled ab-initio.


