Ex-post facto sanction, in relaxation of the Jammu and Kashmir Civil Services (Medical Attendance-cum-Allowance) Rules, 1990, is accorded to the reimbursement of medical expenses incurred by ASI Kaku Ram, EXJ815481 of CID CI Jammu for treatment of his wife namely Smt. Veena Devi at Shri Mata Vaishno Devi Narayana Hospital, Katra, Reasi and Kidney Hospital & Lifeline Medical Institution Jalandhar, Punjab, subject to the following conditions:-

- i) Reimbursement of charges is restricted to items /procedures admissible under rules for the period of hospitalization, w.e.f. 13.03.2017 to 07.08.2017 at Shri Mata Vaishno Devi Naryana Hospital, Katra, Reasi and w.e.f 12.08.2017 to 31.08.2017 at Kidney Hospital & Lifeline Medical Institution, Jalandhar, Punjab and cost thereof is restricted to the extent of rates, applicable to such items/procedures at AIIMS, New Delhi.
- ii) All relevant medical bills/vouchers are verified and countersigned by the competent medical authority of the hospital wherefrom treatment has been undertaken.
- iii) Follow-up (s), if any are regulated under rules.
