Sanction is hereby accorded to the temporary appointment of Shri Basit Farooq S/o Late Farooq Ahmad Wani HC, No.815/11TH Bn (PID No. ARP-831597) R/o Plang, Tehsil Kangan, District Ganderbal, as Junior Assistant, in the Pay Band of 5200-20200 with Grade Pay of Rs.1900/- (pre-revised) in the Prisons Department, J&K in terms of SRO-43 of 1994.

The appointee shall report to the Director General of Police, Prison Department within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates in original:-

- i. Academic Qualification Certificate.
- ii. Age and Health Certificate.
- iii. State Subject Certificate.
- iv. Certificate from the General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken by him.

The appointee shall be initially on probation for a period of two years. If, on verification, the certificates produced by the appointee prove to be fake or forged, the appointment shall stand cancelled ab-initio. It is further ordered that this appointment will be subject to the condition that he shall qualify the type test with a speed of 35 words per minute, as a condition for joining, to be conducted by the concerned HOD.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Additional Director General of Police, CID, J&K to whom a reference shall be made by the Director General of Police, Prisons Department, J&K.


