Whereas, a license No. Home -AR.306-J&K/2005 was issued in favour of Shri Sunil Kumar S/o Sobha Ram R/O.New Plot H.No 86,P/S Bakshi Nagar,Jammu Vide endorsement No.Home-AR/09/2005 dated 30-12-2005;

Whereas, Sr. Superintendent of Police, Jammu vide his letter No.CRB/13/51579-80/DPJ dated 29-11-2013 has informed that Shri Sunil Kumar is hardened criminal against whom, .numerous complainants have been received and he is involved in case FIR No. 285/2001 u/s 307/382/452/148/149-RPC,4/25 Arms Act of P/S Bakshi Nagar Jammu and case FIR No.24/2007 u/s 307/341/324/326-RPC,4/25 Arms Act of P/S Peermitha;

Whereas, Sr. Superintendent of Police recommended cancellation of the above license issued in favour of Shri Sunil Kumar on the above grounds;

Whereas, a show cause notice was issued to Shri Sunil Kumar vide communication Home/AR/354/2013/450 dated 21-01-2014 where under he was asked to explain his position within a period of 15 days as to why his license may not be revoked in exercise of powers vested u/s 17 of Arms Act 1959;

Whereas, Shri Sunil Kumar has not furnished any reply in support of his defense within the stipulated period of 15 days;

Now, therefore the license No. Home -AR.306/-J&K/2005 issued in favour of Shri Sunil Kumar S/o Sobha Ram R/O, New Plot H. No. 86 P/S Bakshi Nagar Jammu. vide endorsement No. Home -AR/09/2005 dated 30-12-2005 is hereby revoked in exercise of powers vested u/s 17(b) of Arms Act 1959.
