Jammu, the 14th September, 2020

S.O. 293 -In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973, the Government hereby declares "Pakal" (Dam site, Pakaldul Hydro Electric Project) & "Dul" (Power House site, Pakaldul Hydro Electric Project) in District Kishtwar, Jammu, as police posts, in respect of the areas mentioned in the **Annexure** to this notification.

These police posts shall be made operational through adjustment from the available staff, taking into account winding up of various police units recently.

The Chenab Valley Power Project (Pvt) Limited (CVPPPL) shall bear the expenses on account of salaries and allowances of the police personnel, apart from providing necessary facilities/accommodation to the police posts for office and residential purpose to establish these police posts.


