Sanction is hereby accorded to the temporary appointment of Mst. Hassena Akhter Wd/o Late Shri Ali Mohammad Lone No F-12/ Awt Exk 984931) R/o Darganiegund Tehsil Tral, District Pulwama as Follower in the pay scale of Rs. 4440-7440 with grade pay of Rs. 1300/- in J&K Armed Police in relaxation of rules as an exception with relaxation in qualification bar and condonation of delay by 1 year and 17 days for filling of application to seek the benefit under SRO-43 of 1994.

The appointee shall report to the Director General of Police, J&K, within a period of 21 days from the date of issuance of this order and shall be allowed to join only after production of the following documents/ certificates in original:-

- 1- Academic Qualification certificate.
- 2- Age and Health Certificate.
- 3- State Subject Certificate.
- 4- Certificate from the General Managers, DIC concerned and Deputy Director, Employment concerned to the effect that no Loan under Self Employment Schemes has been taken by her.

If on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to her unless satisfactory report about the verification of her Character and Antecedents is received from the Inspector General of Police, CID, J&K to whom a reference shall be made by the PHQ. She shall furnish an affidavit to the effect that in case any adverse report about her Character and Antecedents is received from the CID, J&K, she shall have no right to claim the appointment and her appointment as Follower in the J&K Armed Police shall be deemed to have been cancelled ab- initio.
