In terms of clause (s) of section 2 of the Code of Criminal Procedure, 1973, sanction is hereby accorded to:

A. creation of following Police Units:

- i) Police Station, Shalteng, District Srinagar.
- ii) Police Station, Sangam, District Srinagar.
- iii) Police Post, Khimber under the Police Station Zakoora, District Srinagar.
- iv) Police Post, Tengpora under the Police Station, Batamaloo, District Srinagar.
- v) Police Post, Mouchwa under the Police Station, Chadoora, District Budgam.

B. up-gradation of:

- i) Police Post, Bemina to Police Station, Bemina.
- ii) Police Post, Chanapora to Police Station, Chanapora.
- iii) Police Post, Ahmed Nagar to Police Station, Ahmed Nagar.

The territorial jurisdiction of these Police Units shall be notified separately.


