- vii. All other relevant documents as are required under SRO-43/1994.

The appointment of the appointee shall further be subject to the following conditions:

a. That he shall give an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification certificates or any other certificate from the concerned issuing authority are found fake/forged, the claim of the appointee for appointment as Follower in J&K Police shall

- be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) above is received in his favour.
- c. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- d. If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio, without any further notice.
