

Whereas, the IGP, Kashmir Zone, being the Authorized Officer under the Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017, has issued directions to the Telecom Service Providers (TSPs)/Internet Service Providers (ISPs) to suspend mobile data services in Hassanpora area (latitude 33.7750947 and longitude 75.0697517 with 05 kilometers of radius from encounter site) of District Kulgam w.e.f 1700 Hrs. on 09.01.2022 to 1300 Hrs. on 10.01.2022; and

Whereas, the order/letter under reference inter-alia mentions about the encounter between the Security Forces and the terrorists in Hassanpora area of District Kulgam leading to neutralization of 02 terrorists and recovery of arms & ammunition, besides other incriminating material. It is further mentioned that there was every likelihood of misuse of data services by the anti-national elements/OGWs to communicate with their sympathizers for mobilizing crowds, and disturb the law and order situation.

Now, therefore, upon consideration of the various aspects, as brought out in the material provided by the Authorized Officer, I, Principal Secretary to the Government, Home Department, being satisfied that there was absolute necessity of issuance of the aforesaid directions by the Authorized Officer, without obtaining prior approval of the Competent Authority, in the interest of sovereignty and integrity of India, the security of the State and for maintaining public order, hereby confirm order No. 96(TSTS) of 2021 dated 09.01.2022, under endorsement No. KZ/CS/Snap-down/2021 dated 09.01.2022, issued by the Authorized Officer, in exercise of powers conferred under sub-rule (1) of Rule 2 of the Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017.
