**Government Order No: Home -08(TSTS) of 2021**  
**Dated: 19.02.2021**

Whereas, the IGP, Kashmir Zone, being the Authorized Officer under the Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017, has issued directions to the Telecom Service Providers (TSPs)/Internet Service Providers (ISPs) to suspend 2G mobile data services in the District Shopian w.e.f 2340 Hrs. on 18.02.2021 to 2115 Hrs. 19.02.2021; and

Whereas, the order/letter under reference inter-alia mentions about the encounter between the Security Forces and the terrorists in Badigam area of District Shopian leading to neutralization of 03 terrorists and recovery of arms & ammunition besides other incriminating material. It is further mentioned that there was every likelihood of misuse of data services by the anti-national elements/OGWs to communicate with their sympathizers for mobilizing crowds, and disturb the law and order situation, and the miscreants in District Shopian had started exploiting the situation by way of circulation of incriminating material online.

Now, therefore, upon consideration of the various aspects, as brought out in the material provided by the Authorized Officer, I, Principal Secretary to the Government, Home Department, being satisfied that there was absolute necessity of issuance of the aforesaid directions by the Authorized Officer, without obtaining prior approval of the Competent Authority, in the interest of sovereignty and integrity of India, the security of the State and for maintaining public order, hereby confirm order No. 467(TSTS) of 2021 dated 18.02.2021, under endorsement No. KZ/CS/PC-Sgr/snap/21/259-60 dated 18.02.2021, issued by the Authorized Officer, in exercise of powers conferred under sub-rule (1) of Rule 2 of the Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017.
