Subject: Final Seniority List of the members of the Jammu and Kashmir Police (Gazetted) Service, [Deputy Superintendent of Police (Executive)], as on 18.05.2020.

Whereas, in pursuance of Rule 9 of the Jammu and Kashmir Police (Gazetted) Service Rules, 2002, notified vide SRO-132 of 2002 dated 03.04.2002, it is imperative to maintain an up-to-date seniority of the members of the service; and

2. Whereas, a Tentative Seniority List of the members of the Jammu and Kashmir Police (Gazetted) Service [Deputy Superintendent of Police (Executive)], as it stood on 18.05.2020, was issued vide Government Order No.198-Home of 2020 dated 23.09.2020, for inviting objections, if any, from the officers to the inter-se-seniority position assigned to them, in the said Seniority List, within 21 days from the date of its issuance; and


3. Whereas, in pursuance of the above, 48 representations were received from various officers, which were examined by the Home Department in consultation with the PHQ; and

4. Whereas, before finalization of the aforesaid Tentative Seniority List, it was considered appropriate to afford an opportunity of being heard to these representees. Accordingly, on 5th April, 2021, personal hearing was given to them through virtual mode and their contentions were taken note of, also explaining the basis/principles to them; and

5. Whereas, the officers in their representations have raised various issues. These issues have been examined with reference to the factual position and applicable rules. These representations are, therefore, disposed of as per the decisions contained in **Annexure-A**.

6. Now, therefore, the Final Seniority List of the members of the Jammu and Kashmir Police (Gazetted) Service [Deputy Superintendents of Police (Executive)] as on 18.05.2020, forming **Annexure-B**, to this order is hereby notified for information of the concerned members of the service, which shall be subject to the conditions that:

- i) The inter-se-seniority position of the members of the Service, shall be without prejudice to the outcome of writ petition(s), if any, pending in any competent court(s) of law; and



- ii) The date(s) of birth reflected in the Seniority List shall in no manner be construed as final and shall be subject to the entries recorded in the individual service books/date of birth certificates, issued by the Competent Authority.




