**Subject: Accord of Administrative Approval for Augmentation/Up-gradation of Security arrangements and outer periphery area of District Jail Baderwah.**

In terms of S.O-15 of 2020 dated 09.01.2020, Administrative Approval is hereby Accorded for Augmentation/Up-gradation of Security arrangements and outer periphery area of District Jail Baderwah for an amount of Rs. 890.00 Lacs (Rupees Eight Crore, Ninety lacs only) subject to the following terms and conditions:

The works shall be executed after observing all codal formalities

- i) The works shall be executed strictly as per relevant provisions of GFR-2017. Manual for Procurement of Works-2019 and other related instructions
- ii) That the proposal shall be strictly devised and designed as per latest relevant I.S. codes and specifications of PWD/CPWD.
- iii) That the Electrical/Mechanical/Electronic Components are authenticated and technically vetted by the competent authorities of relevant field.
- iv) That the standard specifications are followed as per CPWD, NBC and I.S. standards.
- v) That the rates for the items, not covered in JK SSR or any other relevant Schedule, shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by the competent authority well before invitation of tenders in percentage or fixed as made for certain components of the DPR are provisional and shall be subject to detailed estimates based on actual design details/requirements and relevant rates, to be framed and approved by competent authorities well before invitation of tenders in accordance with set codal procedures.
- vi) That the lump-sum provisions, either in terms of percentage or fixed as made for certain components of the DPR are provisional and shall be subject to detailed estimates based on actual design details/requirements and relevant rates, to be framed and approved by



competent authorities well before invitation of tenders in accordance with set contract procedures.

- vii) That the drawings/proposals are approved by the indenting department before putting the work tender/execution.
- viii) That the proper inventory is made for serviceable materials, available from demolition, for their reutilization in the execution of the project.
- ix) That the cost of serviceable materials, to be re-utilized in the execution of the project, is deducted at relevant rates.
- x) That e-tendering mode is followed for fixation of the award of contract for execution of the project, Fragmentation of project, while tendering, is not allowed.
- xi) The Technical Vetting is exclusively for the purpose of Accord of Administrative Approval and shall not be construed as any rate approval to the project or any approval for inclusion in the plan.


