- 4. Certificate from the General Managers, DIC concerned and Deputy Director, Employment concerned to the effect that no Loan under Self Employment Schemes has been taken by her.

If, on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be treated to have been cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to her unless satisfactory report about the verification of her Character and Antecedents is received from the Additional Director General of Police, Criminal Investigation Department, J&K, to whom a reference shall be made by the Police Headquarter. She shall furnish an affidavit to the effect that in case any adverse report about her Character and Antecedents is received from Additional Director General of Police, Criminal Investigation Department, J&K, she shall have no right to claim the appointment and her appointment as Follower, in the J&K Police, shall be deemed to have been cancelled ab-initio.
