In terms of the J&K Compassionate Appointment Rules, 1994 notified vide SRO-43 dated 22.02.1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of Mr. Makhan Lal S/o Late Ram Lal (Ex-Safaiwalla) R/o Village Kheen, Tehsil Ramnagar District Udhampur, as Safaiwalla, in the Pay Band of Rs. 4440-7440 with Grade Pay of Rs. 1300/- in the Prisons Department, in relaxation of prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the Director General of Police Prisons J&K within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates in original to be verified subsequently:-

- i. Academic Qualification certificate.
- ii. Age and Health Certificate.
- iii. Permanent Resident Certificate.
- iv. Dependent Certificate issued by the concerned Assistant Commissioner, Revenue.
- v. All other relevant documents as are required under SRO-43/1994.
- vi. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.

The appointee shall be initially on probation for a period of two years. If, on verification, the certificates(s) produced by the appointee are proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio, without any notice.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his Character and Antecedents is received from the Inspector General of Police, CID, J&K, to whom a reference shall be made by the Police Headquarters.


