In pursuance to the Government Order No. 723-(GR)GAD of 1990 dated 10.07.1990 read with Government Order No. 823-JK(GAD) of 2022 dated 12.07.2022, sanction is hereby accorded to the grant of ex-gratia relief amounting to **Rs. 25.00 Lakh (Rupees Twenty Five Lakh only)** in favour of NOKs of the martyred Army personnel Sh.
