Whereas, in terms of order No. 1535 of 1990 dated 06.08.1990, issued from DPO, Jammu, Ms. Geeta Sambyal, No. 1464/J, PID No. EXJ-905516, was appointed, on compassionate basis, as Constable in the Police Department; and

Whereas, during scrutiny of the character rolls and academic qualification testimonials of all the police personnel by a committee of officers constituted vide Order No. 1434 of 2006 dated 31.08.2006, issued by DPO, Jammu it came to fore that the date of birth reflected as 29.07.1964 in her Character Roll had been mutilated, which was subsequently established by the FSL. Upon further verification and as per the School record, it has been found that her actual date of birth is 29.07.1961 instead of 29.07.1964; and

Whereas, an inquiry has been conducted by the Police Department in which it has been established that the actual date of birth of the official is 29.07.1961. Apart from this various aspects connected to the alteration of the date of birth in the Character Roll of the official have been brought to fore, which require further examination; and

Whereas, upon scrutiny of the available records, the findings of the Forensic Science Laboratory, reports of the Inquiry officers and keeping in view the rules governing the alteration of date of birth, contained in the Jammu and Kashmir Civil Services Regulations, 1956 and the circular instructions issued in this regard, it has been decided to make a correction in the recorded age of the official in her character roll, reflecting the same as 29.07.1961 instead of 29.07.1964, by virtue of which the official shall retire on superannuation, on 31.07.2021.

Now therefore, in terms of Article 35-AA(d) of the Jammu and Kashmir Civil Services Regulations, 1956, sanction is hereby accorded to the

adoption of date of birth of L/Sgct. Geeta Sambyal, No. 1464/J, PID No. EXJ-905516, as 29.07.1961.
