Whereas, the Police Headquarters, J&K vide referred letters submitted case of ASI Joginder Kumar, PID No. EXJ-876078, for adoption of his date of birth as 20.09.1964 instead of 20.04.1964, on basis of the recommendations of its "Date of Birth Committee"; and

- 2. Whereas, on the basis of information and other relevant documents, it came to fore that ASI Joginder Kumar, PID No. EXJ- 876078 was initially appointed as Constable in J&K Police in the year 1987 and during preparation of the Character Roll, his date of birth came to be recorded as 20.04.1964 in digits and as "Twentieth of April N H Sixty Four" in words, on 1st page of the Character Roll, instead of 20.09.1964; and
- 3. Whereas, the case was examined in light of the factual details, documents made available by the PHQ and the extant rules governing the subject and it was observed that designated committee in PHQ has not considered the relevant rule position as envisaged in J&K Police Rules, 1960 and the Jammu and Kashmir Civil Services Regulations, 1956, while recommending the case of the official for adoption of his date of birth as 20.09.1964; and
- 4. Whereas, the Article 35-AA(c & d) of J&K Civil Services Regulations-Volume-1 explicitly lays down that the alteration in date of birth can be effected within 05 years from the date of entry into Government Service; and
- 5. Whereas, it was observed that the official has failed to make a representation for alteration/modification of his recorded date of birth within the prescribed, time limit i.e. five years from the date of appointment, as required under the provisions of rules and the case has been brought to the notice of the Administrative Department after a lapse of almost three decades. As such, the case for change of Date of Birth warrants rejection.



Now, therefore, the claim of ASI Joginder Kumar, PID No.EXJ876078, after having been examined and considered in terms of the relevant rules governing the field, is for the reasons recorded herein above, found devoid of merits and is therefore rejected. The date of birth of the official shall continue to be treated as 20.04.1964, in figures and Twentieth of April N H Sixty Four in words, as already recorded in his Character Roll.
