In pursuance of the order dated 23.02.2021 passed by the Hon'ble Central Administrative Tribunal, Jammu, Bench Jammu in T.A No. 1997/2020 titled *Dr. Ajaz Ahmad Malik vs. State of J&K and others* and in partial modification of the Government Order No.1163-Home of 2017 dated 22.08.2017, issued under endorsement No. Home/Gaz/PB-I/70/15, it is hereby ordered that:



- (i) the penalty of withholding of increments of Dr. Aijaz Ahmad Malik, DySP, shall be deemed to have remained in force for a period of two years only viz. 2016 and 2017; and
- (ii) the words "Without Prejudice to final outcome of Regular Departmental Action, pending against him" appearing in para 17(i) of the Government Order No.1163-Home of 2017 dated 22.08.2017 shall be deemed to have been omitted.

It is further ordered that the period of suspension of Dr. Aijaz Ahmad Malik, Dy.SP w.e.f. 03.09.2015 to 22.08.2017 shall be treated as on leave whatsoever kind due to him, in terms of Government Instructions appended to Article 108-C of the J&K Civil Services Regulations.
