**Government Order No. Home- 21 of 2020.**

**D A T E D: 24 .01.2020.**

1. Whereas, on 12.02.2003, a Police Gypsy bearing Reg. No. 4026-JK02Q was on its way from Konibal to Pampore and on reaching Konibal Bus Stop was hit by a land mine resultantly one police personnel namely Aijaz Ahmad died on spot.
2. And whereas, the legal heirs of the deceased police personnel preferred a claim petition before the Hon'ble MACT, Pulwama titled Abdul Gani Mir and another vs State of J&K and ors contending therein that the said accident occurred exclusively by use of Motor vehicle belonging to respondents.
3. And whereas, Hon'ble MACT Pulwama vide its Judgment/Award dated 09.12.2017, decided the claim petition in favour of the petitioners and awarded a compensation of Rs.386600/- in equal proportions along with 6% interest from the date of filing of claim petition till its realization.
4. And whereas, the matter was examined in consultation with the Department of Law, Justice & Parliamentary Affairs, J&K and sanction was accorded to the filing of appeal against the judgment dated 09.12.2017 along with drawal of an amount of Rs.25000/- as statutory amount in favour of Director General of Police, J&K for deposition of the same before the Hon'ble High Court of J&K at Srinagar for filing of appeal in the instant claim petition.
5. And whereas, the execution court while hearing the instant claim petition passed an order on 16.11.2019, and attached the Account Head 2055 of Director General of Police, J&K.
6. And whereas, PHQ vide communication dated 22.11.2019, intimated the department regarding the attachment of account head of Director General of Police, J&K and requested that necessary sanction may be accorded for drawal of the entire awarded amount.

7. Now, therefore, sanction is hereby accorded to the drawal of award amount of Rs.5,04,619/- (Rupees five lakh four thousand six hundred and nineteen only) in claim petition titled Abdul Gani Mir and another vs State of J&K and ors, in favour of Director General of Police, J&K, Jammu under Major Head: 2055-Police, Non-Plan (Normal), Detailed Head "633-Compensation", for the current financial year 2019-20 enabling him to deposit the entire award amount before the Registry of Hon'ble High Court of J&K at Srinagar.
8. The expenditure shall be booked after observing all the codal provisions and vouchsafing the availability of funds under the Detailed Head 633-Compensation below Major Head 2055-Police.
