Government Order No. 237 –Home of 2020 Dated: 09.12.2020

Whereas, Mr. Ajay Pal Singh S/o Late Madan Lal R/o Ward No.3, Kasba and Police Station Shishgarh, Bareilly, Uttar Pradesh filed a complaint in the Hon'ble National Human Rights Commission alleging therein that his sister namely, Ms. Suman, resident of Kathua, Jammu, was set on fire by her husband and other accused persons, on 17.09.2016, who succumbed to her injuries in the Hospital on 01.10.2016; and,

Whereas, the Hon'ble NHRC in terms of its order dated 05.03.2020 was, inter-alia, pleased to observe/direct as under:

"....Let the show cause notice u/s 18 of PHRA be issued to Chief Secretary, Government of Jammu and Kashmir, as why not Commission should recommend a compensation of Rs.1,00,000/-(Rs. One Lakh only) be paid to the complainant, as his human rights have been violated by the errant police officials by not registering the cognizable offence and for not taking any action on the same, State is vicariously liable for the same, response within four weeks...."; and,

3. Whereas, the aforesaid direction regarding payment of compensation to the complainant was subsequently confirmed by the Hon'ble NHRC, vide its order dated 04.09.2020. Accordingly, in due deference of the

aforesaid order, sanction has been accorded to the drawal of Rs.1,00,000/-(Rupees One Lakh only) in favour of Mr. Ajay Pal Singh (NOK of late Ms. Suman, sister of the complainant), vide Government Order No.225-Home of 2020 dated 16.11.2020; and,

- 4. Whereas, a departmental enquiry has already been initiated by the PHQ against Mr. Saroop Singh, No.EXJ-006539, the then SHO P/S Kathua, for his failure to register a cognizable offence that took place in September, 2016, within the territorial jurisdiction of P/S Kathua.
- 5. Now, therefore, Mr. Saroop Singh, Inspector No.EXJ-006539, the then SHO P/S Kathua is hereby placed under suspension with immediate effect.
