Whereas, the Director General of Police, J&K vide above referred communication recommended the case of Sh. Mohammad Amin, HC, PID No.EXK-921792, for correction/ adoption of his date of birth as 'First of May Nineteen Hundred and Sixty Six' instead of 'First of May Nine Hundred and Sixty Six', as recorded in words in his Character Roll; and,

Whereas, on examination, it was found that the official came to be appointed as constable in J&K Police in the year 1992 and during preparation of his Character Roll, while his date of birth was recorded correctly as 01.05.1966 in digits, it was recorded wrongly as 'First of May Nine Hundred and Sixty Six'in words, on the 1st page of his Character Roll; and,

Whereas, a Departmental inquiry initiated by PHQ to fix the responsibility for incorrect recording of date of birth of the official revealed that the delinquent official had retired and therefore no disciplinary action could be taken; and,

Whereas, the DOB certificate, issued by Jammu & Kashmir State Board of School Education (JKBOSE), and verified from Joint Secretary JKBOSE, confirms that the date of birth of the official is 01.05.1966; and,

Whereas, the entry recorded in words in the Character Roll of the official is apparently a clerical mistake since the year of birth cannot be 'Nine Hundred and Sixty Six';

Now, therefore, sanction is hereby accorded to modify the entry made in words to 'First of May Nineteen Hundred and Sixty Six' as regards the date of birth of Sh. Mohammad Amin, HC, PID No.EXK-921792 which stands already recorded as 01.05.1966, in digits, in his Character Roll.
