Sanction is hereby accorded to the temporary appointment of Mst. Wahida Akhter W/o Late Constable Reyaz Ahmad Sheikh No. 1684/A (PID No. EXK-003261) R/o Village Uttersoo, Tehsil Shangus, District Anantnag, as Follower, in the pay level SL 1 (14800-47100) in the J&K Police in relaxation of the prescribed qualification and upper age bar in terms of Rule-7 of SRO-43 of 1994.


The appointee shall report to the Director General of Police, J&K within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:-

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Domicile Certificate.
- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- v. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- vi. No loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
- vii. All other relevant documents as are required under SRO-43/1994.

The appointment of the appointee shall further be subject to the following conditions:-

a) That she shall give an undertaking in the shape of an Affidavit to the effect that:-

- i. In case an adverse report about her Character and Antecedents is received from the Additional Director General of Police (CID), J&K, to whom a reference shall be made by the PHQ, she shall have no right to claim her appointment which, shall be deemed to have been cancelled ab-initio;
- ii. If, on verification, genuineness of the qualification certificates from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled ab-initio.



- b. The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (i) and (ii) above are received in her favour.
- c. The appointee shall be initially on probation for a period of two years:
- d. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- e. If the appointee fails to join within a period of 21 ( twenty one) days from the date of issuance of this order, she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio, without any further notice.
