Subject: - Individual Arms Licenses issued in the State of Jammu and Kashmir-instructions thereof.

## Government Order No: - 264 Home of 2019 Dated:- 07/03/2019

Whereas, the Home Department, on the basis of inputs/reports from various agencies particularly CID of J&K Police and Ministry of Home Affairs, Government of India regarding indiscriminate issuance of Arms licenses within the State of Jammu and Kashmir, in terms of Government Order No. 922-Home of 2018 dated 12.07.2018, ordered as under:

i) No fresh individual fresh license shall be issued by the District Magistrate(s) of the State of Jammu and Kashmir in terms of section 14(1)(b)(ii) of the Arms Act, 1959, till further orders;

- take urgent steps to revoke all such Individual Arms Licenses issued to various persons (excluding the personnel belonging to the State Police, Army and CAPFs), consequent to the notification of Arms Rules, 2016, as do not meet all the conditions prescribed in Rule 11 and Rule 12 of Arms Rules, 2016. Further, the District Magistrate shall direct all such persons, whose license is revoked, to deposit any arms or ammunition, with the officer I/C of the nearest Police Station, in terms of the Section 21 of the Arms Act, 1959 failing which action as warranted under law shall be initiated. This action shall be concluded within 15 days of issue of this order and compliance reported to the Home Department.
- iii) Further, all District Magistrates shall ensure strict compliance with the provisions contained in Arm Rules, 2016, at the stage of renewal of an Arms License.
- 2. Whereas, the matter related to the issuance of Arms Licences in the State of Jammu and Kashmir, also came up for discussion in a meeting taken by Election Commission of India during its visit to the State in context of ensuing General Elections, 2019; and

- Whereas, the Home Department has, accordingly, reviewed the 3. matter in light of the discussions held in the meeting with ECI and also in context of the directions issued vide aforementioned Government Order; and
- Now, therefore, with a view to ensure maintenance of law and order in 4. the State, particularly, during the ensuing General Elections, 2019, it has been found expedient to issue the following directions/instructions to all the District Magistrates and District SSsP/SsP for strict compliance:
  - The District Magistrates shall furnish the details of the individual Arms Licences issued by their offices for the period 2012 upto 12.07.2018 to the respective SSP/SP by or before 9th of March, 2019;
  - (ii) The concerned SSP/SP shall, on receipt of such details, conduct an intensive verification of those licenses which have been issued to persons within his/her jurisdiction within a period of seven days and ensure adherence to ECI instructions regarding deposition of the licenced weapons;
  - (iii) The Concerned SSP/SP shall, also, in respect of those State Subjects who belong to other Districts of J&K, immediately take up the matter with the SSP/SP of the domicile District of the licencee for the purpose of verification of licence and adherence to ECI instructions regarding deposition of the licenced weapons;
  - (iv) The District SSsP/SsP, on receiving the above information from District Magistrates shall also verify and reconcile the information with the details of the Arms licences maintained in Form No. 123 (Form H) appended to Jammu and Kashmir Police Rules, 1960 (copy enclosed), as provided under Rule 537 of the aforesaid Rules.
