Whereas, DGP, J&K vide letter No.Estt/DOB-21/2019/34280 dated 23.06.2022, has recommended adoption/correction in date of birth recorded in the service record of Constable Sunny Raina No. EXK098737 as **30.11.1983**, instead of **31.11.1983**; and

Whereas, the date of birth of Constable Sunny Raina, No. EXK-098737 was inadvertently recorded as 31.11.1983, in the Matriculation certificate dated 03.06.2000, under Roll No. 2129094, issued by the Central Board of School Education : and

Whereas, the official was appointed as Constable in J&K Police in the year 2009 and during preparation of his Character Roll, his date of birth was recorded as **31.11.1983 in digits** and as "Thirty first November Nineteen Hundred Eighty three" *in words* on the 1<sup>st</sup> page of his Character Roll, on the basis of certificate issued by the Central Board of School Education; and

Whereas, subsequently in compliance of the directions of the Hon'ble High Court J&K, Srinagar in OWP No. 707/2018, MP No.01/2018 titled *Sunny Raina Vs Union of India and Ors*, the Central Board of School Education, Ajmer, corrected the date of birth of the official as 30.11.1983; and

Now, therefore, in terms of Rule 35 AA (d) of Jammu & Kashmir Civil Services Regulations Volume-I, sanction is hereby accorded to the adoption/correction in date of birth in the service record of Constable Sunny

Raina No. EXK098737 as "30.11.1983", in digits and "Thirtieth November Nineteen Hundred Eighty three", in words.


