Sanction is hereby accorded to the Constitution of a Police Recruitment Board with the following composition, to oversee/monitor the first three phases of recruitment (viz. Physical Endurance Test, Physical Measurement Tests & Written Test) to the posts of Sub-Inspectors (SIs) in Police Department, which will be conducted through the Transparent Recruitment Process (TRP) after fulfillment of all procedural and codal formalities as prescribed by the Government:-
