In pursuance to the Government Order No. HOME-92 of 2020 dated: 20.03.2020, sanction is hereby accorded to the grant of ex-gratia relief of **Rs. 20.00 lacs** (Rupees Twenty Lacs only) in favour of NoKs of the deceased **Shri Satish Kumar Raina SG Fireman No. 415** of Fire & Emergency Services, J&K, who lost his life while performing his duties in a fire incident at residential house near Catholic Church, Prem Nagar, Jammu on 13.01.2023.

This sanction is subject to the fulfillment of following conditions:

- I. Director, Fire & Emergency Services, J&K shall verify full particulars viz., Name/Parentage/Residential Address/Bank details etc. of the above NoKs/beneficiaries at the time of disbursement of ex-gratia amount as per detail shown against each.
- II. Payments to the NoKs/beneficiaries shall be made through the Director Fire & Emergency Services, J&K who shall obtain the acknowledgement receipts from the above NoKs/beneficiaries and submit the same along with all the necessary documents/details to the Home Department, J&K.
- III. The amount shall be released by the Financial Commissioner (Additional Chief Secretary), Home Department, J&K to the Director, Fire & Emergency Services, J&K enabling him to disburse the same among the NoKs/beneficiaries of the deceased employee, by debit to Major Head: 2055-Police, Sub Head: 0957-Internal Security, Detail Head: 032-Relief & Rehabilitation during financial year 2023-24.


