Adoption of date of birth in respect of Sgct. Abdul Hamid Dar, PID Subject:-No. EXK-972528.

Reference:- PHQ letter No. Estt/DOB-34/2018/20259-62 dated 03.04.2021 from Police Headquarters, J&K.

Whereas, the Police Headquarters vide above referred letter submitted case of Sgct. Abdul Hamid Dar, PID No.EXK-972528, for adoption of date of birth of the official as 01.03.1980 instead of 01.03.1979, as recorded in his Character Roll, along with the lower age limit relaxation for a period of 03 months and 08 days; and

- Whereas, PHQ submitted a certificate issued by the Jammu & Kashmir State 02. Board of School Education (JKBOSE), along with the case to substantiate the claim of the official with regard to alteration of his date of birth; and
- Whereas, the examination of the documents relevant in the context of case 03. revealed that the official came to be appointed as Constable in J&K Police in the year 1997 and his date of birth was recorded as 01.03.1979, instead of 01.03.1980, which is without any cutting, overwriting or mutilation; and
- Whereas, a Departmental enquiry was initiated in the matter by SSP Srinagar 04. and the said enquiry was finalized with the recommendations to drop the charges against the delinquent officials owing to non-availability of records, which reportedly got damaged in the floods of September-2014; and
- Whereas, the DOB Committee of PHQ examined the case and recommended 05. for adoption of the date of birth of the official as 01.03.1980, instead of 01.03.1979. The aforesaid committee of PHQ has recommended the case for adoption of his date of birth as 01.03.1980, knowing the fact that such a change shall render him ineligible for entry into Govt. service. The committee has gone a step further and recommended for adoption of the date of birth along with the relaxation of 03 months and 08 days, without taking into consideration the relevant rule position; and
- Whereas, it transpires that either the official has produced another document 06. at the time of his appointment on the basis of which his date of birth was recorded as 01.03.1979, or the same certificate was produced by him and the DoB was knowingly recorded as 01.03.1979, to make him eligible for entry into Government Service; and

- Whereas, the Article 35-AA(c) of J&K Civil Services Regulations Volume-I explicitly lays down that the alteration in DOB can only be effected within 05 years 07. from the date of entry into Govt. Service; and
- Whereas, the facts and circumstances of the case clearly point out that the official has failed to represent for alteration of his recorded date of birth within the prescribed time limit of five years, as the case was brought to the notice of the Administrative Department after a lapse of almost 02 decades; and
- Now, therefore, the claim of the official namely Sgct Abdul Hamid Dar, PID No. EXK-972528, considered in terms of the relevant rules governing the field, is found devoid of any merit and is hence rejected. The date of birth of the official shall be treated as 01.03.1979, as already recorded on the 1st page of his Character Roll.
