- a) That she shall give an undertaking in the shape of an Affidavit to the effect that if, on verification, genuineness of the qualification certificates from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled ab-initio.
- b) The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (a) above is received in her favour.
- c) The appointee shall be initially on probation for a period of two years.
- d) The appointment of the candidate shall be governed in terms of Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and
