Ex-post facto sanction is hereby accorded to reimbursement of medical expenses incurred by Sgct (M) Ashiq Hussain Mir, PID No. MEG981930 of CKR, Srinagar for undertaking treatment at Sir Ganga Ram Hospital New Delhi w.e.f 06.04.2015 to 14.04.2015 in relaxation of the Jammu and Kashmir Civil Services (Medical Attendance-cum-Allowance) Rules, 1990, subject to the following conditions:-

- i) Reimbursement of charges is restricted to items/procedures admissible under rules for the period of hospitalization and cost thereof is restricted to the extent of rates applicable to such items/procedures at AIIMS, New Delhi.
- ii) All relevant medical bills/vouchers are verified and countersigned by the competent medical authority of the hospital wherefrom treatment has been undertaken.
- iii) Follow-up (s), if any are regulated under rules.
- iv) Reimbursement shall be made by the concerned DDO after following prescribed codal formalities.
