In pursuance of the concurrence conveyed by the Finance Department and approval of the Competent Authority, post facto sanction is hereby accorded to the reimbursement of medical expenses incurred by ASI Gh. Hassan, PID No.ARP811269 of IRP 17th Battalion (now retired), on his treatment at Medanta-the Medicity, Sector-38 Gurugram, Haryana, in relaxation of Rule 6(1) & 6(A) of J&K Civil Services Medical (Attendance-Cum-Allowance) Rules, 1990, subject to the fulfillment of following conditions:

- Reimbursement of charges shall be restricted to items/procedures admissible under rules for the period of hospitalization and cost thereof shall be restricted at the rates applicable in AIIMS, New Delhi.
- ii. All relevant medical bills/vouchers are verified from the relevant medical authority of the hospital wherefrom treatment has been taken.
- iii. Essentiality certificate on Form 2 issued by the hospital authorities is obtained and kept on records.
- iv. Certificate from the Competent Medical Authority (Director Health Services/Principal GMC/other) is obtained to certify that the drugs and services charged are reasonable and to establish

the genuineness of the treatment availed in the said hospital. Certificate should also mention that air lifting of the patient was indispensable in view of the health condition of the patient and he could not travel in any other mode.

v. Reasonability of air lifting charges shall be established by the Director General, Civil Aviation.
