Subject:- Sanction of Scooter Advance in favour of Shri Iqbal Afroz Ahmad Malik, SSP Police Transport Workshop, Srinagar- cancellation of Government Order No.Home-110 (P) of 1991 dated 19.03.1991.

Whereas, vide Government Order No.Home-110 (P) of 2091 dated 19.03.1991, among others, Scooter Advance of Rs.12000/- was sanctioned in favour of Shri Iqbal Afroz Ahmad Malik, SSP, PTWS Srinagar; and

Whereas, the Accountant General, J&K vide communication No.D&R-K/mMisc/2005-06/809-10 dated 16.09.2005 conveyed to Police Headquarters as under:-

“An amount of Rs.12,000/- has been sanctioned in favour of the ibid loanee under Govt. Order No. 110(P) dated 19.03.1991 as per our records. In case, the officer has not drawn the said advance the cancellation orders from the sanctioning authority may be obtained.”

Whereas, the Police Headquarters vide communications dated 20.10.2005, 28.06.2007, 4.10.2007, 07.10.2015 and 06.04.2016 have requested for cancellation of Government Order No. 110 (P) of 2091 dated 19.03.1991 in so far it pertains to sanction of Scooter Advance in favour of Shri Iqbal Afroz Malik, SSP PTWS, Srinagar on the ground that the officer has not drawn the Scooter Advance. The Police Headquarters have enclosed the copy of Non-withdrawal Certificate issued by DIG Central Kashmir Range, Srinagar, Non-withdrawal Certificate submitted by CAO PHQ, besides, the Affidavit of the officer and other related documents. These documents lead to the conclusion that the officer has not drawn the Scooter Advance.

Now, therefore, on the basis of the records furnished by the Police Headquarters, sanction is hereby accorded to the cancellation of Government

Order No: 110 (P) of 1991 dated 19.03.1991 in so far it relates to the sanction of Scooter Advance of Rs. 12000/- in favour of Shri Iqbal Afroz Ahmad Malik, SSP, PTWS, Srinagar.


