In terms of S.O-15 of 2020 dated 09.01.2020, Administrative Approval is hereby accorded to the Construction Works of infrastructure for Home guard, CD & SDRF at Samba District for an amount of Rs. 600.74 lacs (Rupees Six Hundred lacs & Seventy Four Thousand only), subject to the following terms and conditions:-

- 1. The works shall be executed after observing all codal formalities.
- 11. The works shall be executed strictly as per relevant provisions of GFR-2017, Manual for Procurement of Works-2019 and other related instructions.
- III. That the proposal shall be strictly devised and designed as per latest relevant LS codes and specifications of PWD/CPWD and same is authenticated and proof checked by the competent authority (NIT/DIQC), before taking up execution in hand.
- IV. That the Electrical/Mechanical/Electronic Components are authenticated and technically vetted by the competent authorities of relevant field.
- V. That the standard specifications are followed as per CPWD, NBC and I.S standards.
- VI. That the specifications as defined in CPWD PLINTH area rate schedule for the type of structures, proposed in the DPR, are followed and adopted for the execution of the works.
- VII. That the rates for the items, not conveyed in JKSSR or any other relevant schedule, shall conform to analysis of rates based on authentic Data Book, to

be computed and approved by the competent authority well before invitation of tenders in accordance with set codal procedures.

- That the lump-Sum provisions, either in terms of percentage of fixed, as VIII. made for certain components of the DPR are provisional and shall be subject to detailed estimates based on actual details/requirements and relevant rates, to be framed and approved by competent authorities well before invitation of tenders in accordance with set codal procedures.
 - That the working BOQs, based on approved design details/requirements, are IX. framed as per J&K PWD Schedule of rates for e-tendering purpose of the project.
 - That e -tendering mode is followed for fixation of the award of contract for X. execution of the project. Fragmentation of project, while tendering, is not allowed.
