Further her appointment shall be subject to the following conditions:-

a) She shall give an undertaking in the shape of affidavit to the effect that in case adverse report about her character and antecedents is received from the CID Headquarters, J&K to whom a reference shall be made by the

Prison Department, She shall have no right to claim her appointment as Superintendent Jail, in the Prison Department and her appointment, as such, shall be deemed to have been cancelled ab-initio;

b) Verification of the genuineness of the qualification and other relevant certificates from the concerned issuing authorities.

The Salary of the appointee shall not be drawn and disbursed to her unless the satisfactory reports in respect of (a) and (b) above in her favour are received by the Prison Department. If, on verification, the certificates produced by the appointee prove to be fake or forged, her appointment shall stand cancelled ab-initio.

The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.

The appointee shall be on probation for a period of two years during which she shall undergo such training and pass the Departmental Examination as

It is further ordered that the seniority of the appointee shall be determined strictly in terms of Rule-24 of the Jammu and Kashmir Civil Service (Classification, Control and Appeal) Rules, 1956.

The above order shall be subject to the outcome of writ petition, if any, pending before any Competent Court of law.
