Sanction is hereby accorded to the purchase of 16 Mobile FSL Vans with Crime Scene Processing Equipments for districts at the cost of Rs. 320.00 lacs (Rs. 20.00 lakh each), sanctioned by MHA, GoI vide No. 17012/2/2021-K.II (IV) dated: 10.05.2021, by the Director Forensic Science Laboratory, J&K.

This sanction is subject to the fulfillment of following conditions:

- a. The purchase shall be affected through SMG and no post of driver shall be created for manning these vehicles.
- b. The purchase of vehicles shall be made as per the approval of the MHA, GoI conveyed vide sanction ibid.
- c. The purchase shall be made after ascertaining reasonability of rates as most economical.
- d. The purchase shall be made strictly as per norms and GFR-2017.
- e. The funds shall be utilized for the purpose for which these have been released and no parking/diversion/re-appropriation of funds at any level shall be allowed.
- f. UC's/Red accounts are furnished to all the concerned quarters and Principal Accountant General (A&E), J&K within the prescribed time limit; and
- g. The Accounts Officer, FSL, J&K shall vouchsafe the availability of funds under the scheme.
