In terms of S.O-15 of 2020 dated 09.01.2020, Administrative Approval is hereby Accorded to the project namely “ **Construction of New District Jail Reasi**” at an estimated cost of Rs. 57.7621 Crores (Rupees Fifty Seven Crore Seventy Six Lacs & Twenty One Thousand only) under UT Capex Budget in favour of Director General of Prisons, J&K. The Administrative Council approved the proposal with the direction that the project shall be completed within three years.

The Administrative approval is subject to the following terms and conditions:-

1. The works shall be executed after observing all codal formalities.
2. The works shall be executed strictly as per relevant provisions of GFR and other related instructions.
3. The proposal is strictly devised and designed as per latest relevant I.S codes and specifications of PWD/CPWD, are authenticated, and proof checked by the competent authority (NIT/DIQC). While designing, adequate provisions in design need to be incorporated for making the structures resistant to earthquakes.
4. That the Electrical / Mechanical / Electronic Components are authenticated and technically vetted by the competent authorities of relevant field.
5. That the standard specifications are followed as per CPWD, NBC and I.S standards.
6. That the specifications as defined in CPWD PLINTH AREA RATE SCHEDULE-2021 for the type of structures, proposed in the DPR, are followed and adopted for the execution of the works.
7. That the rates for the items, not covered in JK SSR or any other relevant Schedule, shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by the competent authority well before invitation of tenders in accordance with set codal procedures.
8. That the lump-sum provisions, either in terms of percentage or fixed as made for certain components of the DPR are provisional and shall be subject to detailed estimates based on actual design details/requirements and relevant rates, to be framed

and approved by competent authorities well before invitation of tenders in accordance with set codal procedures.

9. That e-tendering mode is followed for fixation of the award of contract for execution of the project. Fragmentation of project, while tendering, is not allowed.


