

If, on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be treated to have been cancelled, ab-initio.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about her Character and Antecedents is received from the Additional Director General of Police, CID, J&K to whom a reference shall be made by the PHQ. She shall also furnish an affidavit to the effect that in case any adverse report about her Character and Antecedents is received from the ADGP, CID, J&K, she shall have no right to claim the appointment and her appointment, as Follower, in the J&K Police shall be deemed to have been cancelled, ab-initio.
