In compliance to the order dated 12.02.2019, passed by the Division Bench of the Hon'ble High Court of J&K at Srinagar in PIL No. 18/2014 titled J&K High Court Bar Association vs State of J&K and others and in continuation to Govt. Order No. Home-344 of 2019 dated 28.03.2019, sanction is hereby accorded to the drawal of an amount of Rs.4,55,438/- (Rupees four lakh fifty five thousand four hundred and thirty eight) only out of the claim of Rs.6,23,036, since Rs.1,67,598/- stands already reimbursed. The sanctioned amount is based on bills/ invoices of expenditure incurred by the acid attack victim on her treatment in the following hospitals:

- (i) Sankara Nethralaya, unit of Medical Research Foundation, Main, 41/18 College Road, Chennai,
- (ii) Apollo Hospitals as per bills/ vouchers available.

The amount shall be drawn by the Financial Advisor/ CAO, Home Department out of the funds placed at his disposal by the competent authority for the current fiscal 2020-21 under detailed head 633-Compensation, Sub-Head 2395- Compensation to Victims related to Major Head 2055-Police to be deposited before the Registrar Judicial, Hon'ble High Court of J&K at Srinagar for payment to the victim.


