The appointment of the appointee shall further be subject to the following conditions:

a. That she shall give an undertaking in the shape of an Affidavit to the effect that if, on verification, genuineness of any certificate from the concerned issuing authority are found fake/forged, the claim of the appointee for appointment as

- Follower in J&K Police shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.
- b. The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (a) above is received in her favour.
- c. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- d. If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio, without any further notice.
