In terms of S.O-15 of 2020 dated 09.01.2020, Administrative Approval is hereby accorded to the Construction Works of Women Battalion at Sopore District Baramulla in Kashmir Division and Pargalta, District Jammu in Jammu Division for an amount of Rs. 4947.54 lacs (Rupees Forty Nine Crore Forty Seven Lacs and Fifty Four Thousand only) & Rs. 5029.19 lacs (Rupees Fifty Crore Twenty Nine Lacs and Nineteen Thousand Only) respectively in favour of Director General of Police , J&K, subject to the following terms and conditions:-

1. The works shall be executed after observing all codal procedures.
2. The works shall be executed strictly as per relevant provisions of GFR-2017 and Manual for Procurement of Works-2019.
3. That the proposals are strictly devised and designed as per latest relevant I.S codes and specifications of PWD/CPWD and same is authenticated and proof checked by the competent authority (NIT/DIQC). While designing, adequate provisions in design need to be incorporated for making the structures resistant to earthquakes.
4. That the Electrical/Mechanical/Electronic Components are authenticated and technically vetted by the competent authorities of relevant field.
5. That the standard specifications are followed as per CPWD, NBC and I.S standards.
6. That the specifications as defined in CPWD PLINTH AREA RATE SCHEDULE for the type of structures, proposed in the DPR, are followed and adopted for the execution of the works.
7. That the rates for the items, not covered in JK SSR or any other relevant Schedule, shall conform to Analysis of rates based on authentic Data Book, to be computed and



approved by the competent authority well before invitation of tenders in accordance with set codal procedures.

8. That the lump-sum provisions, either in terms of percentage or fixed as made for certain components of the DPR are provisional and shall be subject to detailed estimates based on actual design details/requirements and relevant rates, to be framed and approved by competent authorities well before invitation of tenders in accordance with set codal procedures.
9. That the Provision for "Construction of RCC reservoir distribution system & bore well at women battalion, at Sopore" amounting to Rs. 20.00 lacs in the DPR is provisional and shall be subject to detailed estimate based on actual details/requirements and relevant rates to be framed and approved by competent authorities well before invitation of tenders in accordance with set codal procedures.
10. That the working BOQs, based on approved design details/requirements, are framed as per J&K PWD Schedule of Rates for e-tendering purpose of the Project.
11. That e-tendering mode is followed for fixation of the award of contract for execution of the project. Fragmentation of project, while tendering, is not allowed.


