Whereas, the Director General of Police, J&K vide above referred letter submitted the case of ASI Mohd. Younis, PID No.ARP-821720, for adoption of his date of birth as 02.12.1961, instead of 02.02.1961, in terms of Article 35-AA of J&K CSR; and,

Whereas, PHQ has reported that the Matriculation Examination certificate issued by Jammu and Kashmir State Board of School Education (JKBOSE), mentions the date of birth of the official as 02.12.1961; and,

Whereas, on examination, it has been found that ASI Mohd. Younis, came to be initially appointed as Constable in J&K Armed Police in the year 1982 and during the preparation of his Character Roll, his date of birth was recorded as 02.02.1961; and,

Whereas, it has come to the fore that date of birth entry in the Character Roll was tampered with, mutilated and overwritten as 02.12.1961. The expert opinion of Forensic Science Laboratory (FSL), J&K was sought in the matter and the report of FSL received from PHQ vide No.Estt/DOB-17/2017/843 dated 06.01.2020, reveals that the tampering/alteration or addition has been made in "Month's Column" on recorded date of birth. The existing digit '1' at the Ten's place in the Month's column of date of birth has been added later on, with the ink of different tint and luster (Shade); and,

Whereas, the official has failed to represent for alteration of recorded date of birth within the stipulated period of time i.e. 05 years from the date of appointment, as required under the provisions of Law; and,

Whereas, it has been taken note of that there has been an inordinate delay in representing for change of date of birth and same has been made only close to the date of retirement.

Now, therefore, the claim of ASI Mohd. Younis, PID No.ARP-821720, having been examined in terms of Rule 35-AA (c) and (d) of Jammu & Kashmir Civil Services Regulation Volume-I, found devoid of any merit, is hereby rejected. The date of birth of the official, recorded at the time of preparation of his Character Roll in 1982, shall continue to be treated as 02.02.1961. The official shall and shall always be deemed to have retired from Government service in the afternoon of 28.02.2021. The salary and other monetary benefits received, if any, by the official beyond 28.02.2021, shall be recovered from the pensionery benefits of the retired official.
