**Subject: Appointment of Shri Haseeb-Ur-Rehman, IPS (SPS:10),

Whereas, an inquiry under Rule 33 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956, is being held against Shri Jagdev Singh Salathia, EXJ-905447, the then SHO Police Station, Domana (now retired SP); and,

Whereas, Shri Imtiyaz Ismail Parray, IPS, the then DIG Training, PHQ, J&K, was appointed as Inquiry Officer, vide Government Order No.255-Home of 2023 dated 13.05.2023, to conduct de-novo inquiry into the charges served upon Shri Jagdev Singh, EXJ905447, the then SHO P/S Domana (now retired SP) vide Memorandum No.Home /Gaz/ Pf/ 53/2013/4938 dated 09.10.2014; and,

Whereas, Shri Imtiyaz Ismail Parray, IPS, the then DIG Training, PHQ, J&K, has subsequently been transferred and appointed as Deputy Inspector General in Sashastra Seema Bal (SSB), vide Ministry of Home Affairs, Government of India communication dated 04.10.2023, read with communication dated 13.10.2023, and it was deemed necessary to appoint another officer as Inquiry Officer to inquire into the charges against Shri Jagdev Singh Salathia, EXJ-905447, the then SHO Police Station, Domana (now retired SP).

Now, therefore, in supersession of the Government Order No: 255-Home of 2023 dated 13.05.2023 and in terms of Rule 33 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956, Shri Haseeb-Ur-Rehman, IPS (SPS:10), DIG, Railways, J&K, is hereby appointed as Inquiry Officer to conduct de-novo inquiry against Shri Jagdev Singh Salathia, EXJ-905447, the then SHO Police Station, Domana (now retired SP). Shri Suhaib Ashraf, Chief Prosecuting Officer, PHQ, shall be the Presenting Officer in the case.

The Inquiry Officer shall complete the de-novo enquiry and submit report to the Home Department within a period of thirty days from the date of issue of this order.
