Ex-post facto sanction, in relaxation of the Jammu and Kashmir Civil Services (Medical Attendance-cum-Allowance) Rules, 1990, is accorded to the reimbursement of medical expenses incurred by Inspr. Javid Iqbal Masoodi, PID No. MEG831724 (now Dy.SP) (M) for treatment of his son namely Ubaid Iqbal at Indraprastha Apollo Hospital, New Delhi, subject to the following conditions:-

- Reimbursement of charges is restricted to items /procedures admissible under rules for the period of hospitalization, w.e.f. 11.08.2010 to 27.08.2010 and cost thereof is restricted to the extent of rates, applicable to such items/procedures at AIIMS, New Delhi.
- All relevant medical bills/vouchers are verified and countersigned by the competent medical authority of the hospital wherefrom treatment has been undertaken.
- Follow-up (s), if any are regulated under rules.
- To ensure that the concerned employee was not covered or required to be covered under any Medical Insurance Policy for Government employees at relevant point of time.
