**Dated: 05-02-2024**

Pursuant to the selection made on the basis of the Competitive Examination as prescribed under Jammu and Kashmir Competitive Examination (Prosecution) Rules, 2021 and on the basis of the recommendations made by the Jammu and Kashmir Public Service Commission, sanction is hereby accorded to the temporary appointment of the candidates as mentioned in **Annexure-I** to this Order, against the posts of Prosecuting Officer (G) in Jammu and Kashmir Prosecution Service, in the Pay Level 8 (47600-151100), with immediate effect.

The appointees shall report in the office of Director General, Prosecution Department J&K, Jammu/Srinagar as per their preference.

The appointees shall be allowed to join only on production of the following certificates in original:

1. Date of Birth Certificate.
2. Qualification Certificate(s).
3. Domicile Certificate.
4. Relevant Category Certificate.
5. Any other documents as required under rules.

Candidate(s) who fail to join within a period of 21 (twenty-one) days from the date of issuance of this appointment order, shall forego their right to appointment, which shall be deemed to have been cancelled ab-initio without any further notice.

Salary of the appointees shall be drawn and disbursed to them after the receipt of the satisfactory reports in respect of genuineness of qualification /Date of Birth/Relevant Category Certificate and subject to production of an affidavit (**as per annexure-II**) to this order. In case, any candidate is adversely reported upon by the verifying agency or any certificate is found not to be genuine /valid, he/she shall have no claim to hold the post to which appointed and his/her appointment shall automatically stand cancelled without any further notice.

The appointment of the selected candidates shall be governed by the following conditions:

- (i) These appointments shall be under "New Pension Scheme" notified vide SRO-400 of 2009 dated 24.12.2009.
- (ii) The appointees shall be on probation for a period of two years.
- (iii) The appointment of all the candidates shall be subject to outcome of the writ petition(s)/O.As/Appeal, if any, pending before any Competent Court of Law/Tribunal.

It is further ordered that the inter-se seniority of the appointees shall be determined in terms of the Rule 10 of the Jammu & Kashmir Prosecution Service Recruitment Rules, 2020.
