Whereas, the IGP, Kashmir Zone, being the Authorized Officer under the Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017, has issued directions to the Telecom Service Providers (TSPs)/Internet Service Providers (ISPs) to suspend 2G mobile data services in Kreeri/Pattan area of District Baramulla, w.e.f 17.08.2020 (2120 Hrs) to 18.08.2020 (2100) Hrs.; and

Whereas, the order under reference inter-alia mentions about the encounter between the Security Forces and the terrorists in Kreeri/Pattan area of District Baramulla, leading to neutralization of 03 terrorist and recovery of arms and ammunition, alongwith other incriminating material. It is also mentioned that there was every likelihood of misuse of data services by the anti-national elements/OGWs to communicate with their sympathizers for mobilizing crowds, and disturb the law and order situation, as has been the practice in the past.

Now, therefore, upon consideration of the various aspects, as brought out in the material provided by the Authorized Officer, I, Principal Secretary to the Government, Home Department, being satisfied that there was absolute necessity of issuance of the aforesaid directions by the Authorized Officer, without obtaining prior approval of the Competent Authority, in the interest of sovereignty and integrity of India, the security of the State and for maintaining public order, hereby confirm order No. 1080(TSTS) of 2020 dated 17.08.2020 issued under endorsement No. KZ/CS/PC-Sgr/20/1983-84 dated 17.08.2020, by the Authorized Officer, in exercise of powers conferred under sub-rule (1) of Rule 2 of the Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017.
